2021-2022 PARENT CODE OF CONDUCT

*Practices are closed. Dancers are to be "Dropped off" at the front entrance door of the studio **no sooner than 5 minutes** before their class time. All dancers must be picked up promptly. **If your child does not have practice or it is not their practice time, they are not to be left here.** All dancers must be picked up promptly. There is a **CHILDCARE FEE** that you must pay to the coach that had to stay after practice to wait for you to return to pick up your dancer. **\$15.00 per every 10 minutes you are late.**

***If dancer is not at practice the week of the competition or show, they will not be permitted to perform at that competition or show. This includes solos.** If doctor's note is provided that the dancer cannot attend class, it will be the coach's decision whether to let the dancer perform/compete or sit that week.

*Payments are due on the **1st** of every month. You may call or text Denny for questions you have. You may only discuss concerns on your account with Denny. There will be **NO REFUNDS OF ANY FUNDS ISSUED.** **There will be a **\$35.00** charge for any returned check.

*****There will be a \$35.00 late fee applied to your account on the 6th day of the month for ANY balances that is still due on your account and this will continue to accrue each month until the account is brought current with a ZERO balance. Any late fees will be deducted first from your payment and the rest of money will be applied to your account.** If your account is late for 2 consecutive months, your child will be asked to leave the company.

*Credits will be subtracted from your account after the second month earned. (i.e., September earned-deducted from November payment). You need to keep track of your credits each month also, and then you will know what to pay each month.

*****If your account is not current, we will not order your child's costume and your child will not be able to perform.**

*****If you choose to leave the competitive dance team after routines are started and before the end of the season, you will be charged \$100.00 re-choreography fee for each routine your child was in.**

*For competitions, times are given to parents for dancers to be ready and in the room, which needs to be followed at each competition. If you would choose to get your dancer ready before you arrive at the school, you are still required to be there at the assigned time. If you leave the school to get food, you must return in time for the dancer to be ready at the assigned time for their next performance and you must notify Krystle that you are leaving. **All** dancers must stay for awards, unless excused by Krystle.

*For Nationals, everyone is required to stay at the same hotel and attend both days of the competition. We try to find the best deal for our money as well as we plan things for the dancers to do. It is also **MANDATORY that you watch and cheer on all our teams competing.**

*It is **MANDATORY** that parents attend all parents' meetings. There will be a \$35 fee if you do not have an adult present from your family.

*There will be a **mandatory fundraiser** that you are required to participate in. This money will be going to the **Dancers Competition Fees.** If no one from your dancers' family participates or works at the fundraiser, **you will be charged the full competition fee.**

*The use of 'Sophistication Dance Company' name or logo may not be used for solicitation purposes without the consent from the director.

*****Under NO circumstances will any negative comments, discrediting of the company or the SDC staff be tolerated and will be grounds for your dancer or dancers immediate dismissal from the company. If you have any questions or concerns, you may speak with any of the SDC staff BEFORE or AFTER practices. You may call them before 9:00pm as well. Do not disrupt practices. Competitions are NEVER the time or place to address any issues. It is very inappropriate and unacceptable to approach SDC staff during this time. All decisions made by the SDC staff are done with the hopes of building a strong and positive company. We always have our dancers' interest at heart when making decisions. We are a dance family and expect everyone to show RESPECT to everyone.**

DANCER CODE OF CONDUCT

Attendance:

- ★ Expected to attend classes regularly. Dancers who miss a class are required to attend make-up classes.
- ★ Expected to be punctual. Warm-up is conducted at the start of every class and it is imperative that all dancers participate in warm-up to ensure that their body is ready for physical activity.
- ★ There to observe a dance class for any reason are expected to be quiet and courteous to the dancers, Dance Teachers, and Assistants and should not disrupt a dance class for any reason.

Attitude:

- ★ Focus in sessions: concentrate, listen and apply corrections.
- ★ Be enthusiastic, committed, interested in learning and strive to become the best dancer you can be.
- ★ Act in a respectful and supportive manner to staff and fellow students always.
- ★ Support, always encourage and work sensibly with fellow students.
- ★ Take responsibility for learning and carry out homework or any practice of corrections in between sessions.
- ★ Always appear in correct uniform in a presentable manner.
- ★ Understand that there is a **NO TOUCHING POLICY** at SDC. Dancers should not touch other dancers, or any members of SDC staff for any reason, unless necessary to perform teamwork-oriented choreography in a dance routine.
- ★ Understand that confidence and self-esteem are at the forefront of SDC mission. Therefore, there will be zero tolerance towards gossip, unkind words spoken towards or about fellow dancers, instructors or SDC staff or any inappropriate behavior. If any of this happens during class, the dancer will be removed from the dance class and parents will be contacted.

Illness or Injury:

- ★ Students are expected to attend and participate in classes, when possible
- ★ If a student has a contagious illness, they **should not attend class**. Your team coach must be notified by phone on that day.
- ★ If a student has an injury and is advised by a doctor not to participate in their practices, they must turn in their **doctors' recommendation slip**, attend all sessions to watch classes and make notes of routines. The **doctors' release form** must have dates off and a return date on it.

Safety and Courtesy:

- ★ If students are more than 10 minutes late to class, they will not be allowed to participate for their own safety.
- ★ Eating in the studio and chewing gum during class is not allowed.
- ★ No food or drink except bottled water should be brought into the studio.
- ★ Dancers are expected to clean up after themselves and any mess that they create while at the studio.
- ★ Dancers must treat the studio, the premises, and the possessions of all other dancers with respect, care and consideration.
- ★ Mobile telephones should be turned off or left on 'silent' mode.
- ★ Dancers are encouraged to establish new friendships with dancers in their classes. We enforce teamwork and fairness, and dancers are expected to treat each other with respect.
- ★ No dancer under the age of 18 is to drive to competitions without an adult with them.
